Parish Council Code of Conduct adopted July 2022

The Localism Act 2011
The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012

Members' attention is drawn to the following notes:

1. The Council's Code of Conduct provides for registration and disclosure of pecuniary interests and interests other than pecuniary interests. This form gives general guidance on those interests that need to be disclosed if you need advice or assistance please speak to the Council's Monitoring Officer. Continuation sheets should be used where needed and clearly marked.
2. Where you consider that information relating to any of your interests is a 'Sensitive Interest', please could you seek the assistance of the Council's Monitoring Officer before you complete and return this Form.
3. A 'Sensitive Interest' is an interest which could create or is likely to create a serious risk that you or a person connected with you may be subjected to violence or intimidation.
4. Where the interest is no longer a 'Sensitive Interest' you must notify the Monitoring Officer within 28 days of that change.
5. Reference to Member is taken to include an elected or co-opted member to the Council.
6. The Council's Monitoring Officer is required to ensure that a copy of the Council's Register of Members Interests is both available for inspection and also that the Register is published on its website.

6. Membership of other bodies

- (a) You must reveal the name of any person from whom you have received a gift or hospitality with an estimated value of at least £25 which you have received in your capacity as a member of the Council.

You are reminded that you must update the register within 28 days of receiving any further gift or hospitality with an estimated value of at least £25 by completing a continuation sheet which may be obtained from the Democratic and Electoral Services Manager.

8. Changes to Register of Interests


- (a) I understand that I must, within 28 days of becoming aware of any new or change in the above interests, including any change in relation to a sensitive interest, provide written notification to the Council's Monitoring Officer.
- (b) I confirm that I understand and accept that that it is a breach of the Council's Code of Conduct to:
- (1) omit information that ought to be given in this Form;
 - (2) provide information that is materially false or misleading;
 - (3) fail to give further notices in order to:
 - bring up to date information given in this Form;

- declare an interest that I acquired after the date of this Form and have to declare

and that any breach of the Code of Conduct can be referred to the Monitoring Officer for action.

- (c) I understand that failure (without reasonable excuse) to register or disclose any disclosable pecuniary interest in accordance with section 30(1) or 31(2), (3) or (7) of the Localism Act 2011, or participating in any discussion or vote in contravention of section 31(4) of the Localism Act 2011, or taking any steps in contravention of section 31(8) of the Localism Act 2011 is a criminal offence and risks a fine not exceeding level 5 on the standard scale (currently £5,000) or disqualification as a member for a period not exceeding 5 years.
